The Toyota Land Cruiser Club has several registered trainers and offers a Nationally Recognised Four Wheel Drive Training course. It is also a pre-requisite of most interstate four wheel drive clubs for members who intend to partake in their trips to hold a Nationally Recognised Four Wheel Drive qualification.

**Information Privacy:**

The information collected for this application is solely for the use of the administration of the TLCC Darwin and the events it conducts. **Membership Options**

- All memberships are based on a 12 month financial year (1<sup>st</sup> July to 30<sup>th</sup> June).
- New membership applications will incur a joining fee and yearly membership fees will be calculated on a pro rata basis per quarter if joining after the 30<sup>th</sup> of September.
- Renewing memberships are not required to pay the joining fee again.
- As per the Toyota Land Cruiser Club Darwin constitution, memberships which are **not paid within 90 days of the due date cease to be a financial member** and will then become null and void unless the Executive Committee determines otherwise.
- A failure to remain a financial member will incur the cost of the joining fee upon reapplication.

As per the Toyota Land Cruiser Club Darwin constitution applications are reviewed by the TLCC Darwin Executive Committee. The Executive Committee reserves the right to deny applications at its discretion. Unsuccessful applicants are entitled to appeal a rejection decision by providing written notice to the Club Secretary within 14 days after being advised of the decision. If after careful reconsideration of the application the TLCC Darwin Executive Committee reaffirms its decision to reject the application, then the Executive Committee decision is final.
